NOTICE TO THE MARKET

**ANTT APPROVES TOLL INCREASE AT
TRIUNFO TRANSBRASILIANA**

São Paulo, December 17, 2015 – Triunfo Participações e Investimentos S.A., (“Company”) (BM&FBOVESPA: TPIS3) and its subsidiary Transbrasiliana Concessionária de Rodovia S.A. (“Triunfo Transbrasiliana”) hereby announce that the National Ground Transportation Agency (“ANTT”) approved the annual adjustment of the basic toll, in accordance with the concession contract, and the submission of the executive project for road widening works at the concessionaire Triunfo Transbrasiliana, which operates the stretch of highway BR-153 in the state of São Paulo.

As published in edition 241 of the Federal Register *Diário Oficial da União* on December 17, starting December 18, 2015, the basic toll will increase from R\$3.70 to R\$4.30, applicable to cars, buses and trucks. The toll for motorcycles, scooters and motorized bicycles will increase from R\$1.85 to R\$2.15. The new toll will be valid at the Company's four toll plazas starting 00:01 a.m. on Friday, December 18, 2015.

The publication also approved the adjustment of the Basic Toll from R\$4.30 to R\$7.70, subject to: (i) submission of the executive project for road widening, including the respective analysis and consent of ANTT; (ii) holding of a public hearing by ANTT; (iii) consideration and approval by the Joint-Decision Board of ANTT; and (iv) communication to the Ministry of Transport and Ministry of Finance prior to the application of the New Basic Toll. The adjustment aims to include in the PER the road widening works in the stretch of highway BR-153/SP between km 0 and km 72, which is the urban stretch in the city of São José do Rio Preto. Note that the total stretch of road widening is 100 km, although the widening of the stretch from km 72 to km 100 was already contemplated in the concession contract, and will be carried out over the next two years.

Triunfo Transbrasiliana operates and manages a stretch of highway BR-153 from the border of the states of Minas Gerais and São Paulo, in the city of Icém (km 0), to the border of the states of São Paulo and Paraná, in the city of Ourinhos, (km 347.7).
