PRESIDING BOARD: Luiz Fernando Wolff de Carvalho chaired the meeting and I, Paula Paulozzi Villar, acted as the secretary.

AGENDA: To consider and vote on the following:

- (i) Approve the Guarantee to be granted to the second tranche of the bridge loan of CONCEBRA Concessionária das Rodovias Centrais do Brasil S.A. with the Brazilian Development Bank (*Banco Nacional do Desenvolvimento*) ("BNDES"), in the amount of up to three hundred million reais (R\$300,000,000.00);
- (ii) Approve the contracting of a Letter of Guarantee to replace the guarantee granted through contract 11.2.0016.1 entered into between NTL and BNDES related to the vessel Maestra Atlântico, in the amount of up to fifteen million five hundred thousand reais (R\$15,500,000.00);
